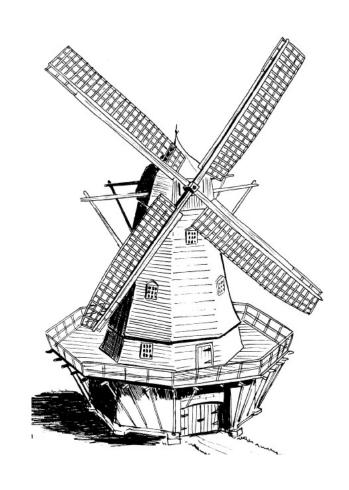
130th Annual Grand Lodge Dania Convention Report

Grand President Roger Gearhart, Danmark #2, called the convention to order at 9:00 A.M. The password was taken by Grand Marshal Kurt, Høj Hejls Minde #23, and Grand Vice Marshal Johanna Gade, Bornholm #14. After the password was obtained the Grand President called for the opening sign.

Before calling the roll, the Grand Secretary reported that a Delegate requested that the official name of the Branches be used. The Grand Secretary explained that the official name of each

Branch as recorded by the Internal Revenue Service is in the same format of "GRAND LODGE OF DANIA OF CALIFORNIA & NEVADA NUMBER BRANCH NAME" and used Danmark #2 as an example "GRAND LODGE OF DANIA OF CALIFORNIA & NEVADA 2 DANMARK" after this explanation the Grand Secretary called the roll using the more familiar branch names. 10 Grand Officers, 26 Delegates and 15 Past Grand Presidents responded to roll call. See addendum for the complete Roll Call results.

The assembly then rose to recite the pledge of allegiance to the flag of the United States of America followed by the singing of the Danish National Anthem, led by Past Grand President Kaj Kristensen, Danmark #2.

Grand President Roger Gearhart, Danmark #2, then declared a moment of silence for those departed members this past year as Grand Marshal Kurt Høj draped the Charter.

Grand President Roger Gearhart, Danmark #2, asked Grand Marshal Kurt Høj to escort the Convention Chairpersons, Grand Trustee George Cumming Jr., Thyra #9, Karen Lysmer, Sønderjylland #10, Grand Vice President Lilian Rasmussen, Sønderjylland #10, and Past Grand President, Robert Lacey, Danneskjold #17, behind the altar. Each of them welcomed the Grand Officers, Delegates and Past Grand Presidents to the 130th Grand lodge Convention.

Grand President Roger Gearhart, Danmark #2, introduced his brother Donald Gearhart of Danmark #2, and pointed out that he and Past Grand President Robert Sorensen were the only two World War II veterans in attendance today.

Grand President Roger Gearhart, Danmark #2, proclaimed the 130th Dania Convention in session with full powers and authority to act. Grand President Roger Gearhart instructed The Grand Marshal Kurt Høj to escort Past Grand President Mr. Mahler, Thyra#9, to the chair on his right to act as his advisor during the Convention.

Minutes from the close of the 129th convention were read. Grand President Roger Gearhart, asked for any errors or addition; there being none he declared the minutes approved as read.

Grand President Roger Gearhart turned the meeting over to Grand Vice President Lilian Rasmussen. The Grand President read his report. (**See addendum**) It was moved by Past Grand President Peder Hoy, Bornholm #14, that we accept the report of the Grand President. Seconded by Rowland McNeil, Thyra #9, and carried with one opposed. The Grand Vice President Lilian Rasmussen, after ruling on the motion, returned the Gavel to Grand President Roger Gearhart.

Report of the Executive Committee was read. It was moved by Past Grand President Kaj Kristensen, Danmark #2, to accept the report. Seconded by Mel Lundberg, Valhalla #11, and carried. (**See addendum**)

Grand Secretary's Report: After the Grand Marshal and Grand Vice Marshal handed out the reports of the Grand Secretary, Grand Treasurer, and The Grand Trustee along with the Reports from the Old Age Fund, the Grand Secretary reminded the Delegates that the financial reports will no longer be a part of the Convention report that is posted on line. After the Grand Secretary's annual report was reviewed Mel Lundberg, Valhalla #11, moved to accept the report.

Seconded by Past Grand President Kaj Kristensen, Danmark #2, and carried. (**See addendum**) The Grand Secretary then called the Delegates attention to the itemized reports of the Branches on Membership, Assets, Receipts, and Disbursements for review. John Schueber, Bornholm #14, moved to accept the report. Seconded by Past Grand President Gunnar Nielsen, Thor #5, and carried. (**See addendum**)

Grand Treasurers Report was presented by Grand Treasure Gregory Gleeson, for reviewed. Past Grand President Kaj Kristensen, Danmark #2, moved to accept the report. Seconded by Karen Lysmer, Sønderjylland #10, and carried. (**See addendum**)

Grand Trustees Report was presented by Grand Trustee George Cumming Jr. due to first Grand Trustee Bent Olsen being out of the meeting room taking care of a problem with the Coffee Break Kringle. After review Past Grand President, Robert Lacey, Danneskjold #17, moved to accept the report. Seconded by Jim Gearhart, Danmark #2, and carried. (**See addendum.**)

Recess at 10:00 A.M. Convention reconvened at 10:35 A.M.

The Grand Marshal collected the password from the new members in attendance.

Grand President Roger Gearhart reminded the Delegates on the correct procedure for entering or leaving the meeting while it is in session.

NEW BUSINESS

Past Grand President Robert Lacey, on behalf of Danneskjold #17, presented a check for \$100.00 to the Memorial Scholarship, which was accepted by the Grand Lodge.

The Grand Secretary called the Delegates' attention to the Annual Report of the Old Age Fund. He reported on the new officers of the fund and thank all those who did attend the meeting held on April 15, 2010. He also asked that those Branches who can afford donate moneys to the Old Age Fund please do so.

Proposed Amendments to the Constitution

The following two amendments were handed out to the Delegates by the Grand Marshal and Grand Vice Marshal

Amendment #1 to the Constitution Danish Society Dania of California and Nevada

$\frac{\text{Article XI}}{\text{RECEIPTS, DISBURSEMENTS AND ASSETS OF THE GRAND LODGE}} \\ \frac{\text{Section 4}}{\text{Funeral and Burial Funds}}$

As written in the Constitution:

Par. 7. Members are entitled to funeral and burial benefits according to their age at the time of their most recent initiation or at the time of their transfer from social and active social members to members entitled to funeral and burial benefits, as follows:

Age 14-50: 100% of funeral benefits set at the convention.

Age 51-55: 75% of funeral benefits set at the convention.

Age 56-60: 70% of funeral benefits set at the convention.

Age 61-65: 50% of funeral benefits set at the convention.

Age 66-70: 40% of funeral benefits set at the convention.

Age 71 and over, 20% of funeral benefits set at the convention.

Change to:

Par. 7. Members are entitled to funeral and burial benefits according to their age at the time of their most recent initiation or at the time of their transfer from social and active social members to members entitled to funeral and burial benefits, as follows:

Age	14-50	100% of funeral benefits set at the convention,
Age	51-55	75% of funeral benefits set at the convention,
Age	56-60	70% of funeral benefits set at the convention,
Age	61-65	50% of funeral benefits set at the convention,
Age	66-70	40% of funeral benefits set at the convention,
Age	71 and over	20% of funeral benefits set at the convention.

Amendment #2 to the Constitution Danish Society Dania of California and Nevada

Article XI RECEIPTS, DISBURSEMENTS AND ASSETS OF THE GRAND LODGE Section 4 Funeral and Burial Funds

As written in the Constitution:

Par.8. No member shall receive any funeral and burial benefits during the first full year of membership in Dania.

Change to:

Par. 8. Members will be entitled to the full funeral and burial benefits described in Par.7. only after ten years or more of membership in Dania. The funeral and burial benefits will be phased in at the rate of 10% of the full benefit for each year of membership up to 100% vested after 10 years. No member shall receive any funeral and burial benefits during the first full year of membership in Dania.

The Grand Secretary moved to accept the Amendment number 1 as presented seconded by Tom Martin Danmark #2 The results were Yes 38 No 0. The Grand President ruled that the motion had passed.

The Grand Secretary moved to accept the Amendment number 2 as presented seconded by Tom Martin Danmark #2 The results were Yes 29 No 2. The Grand President ruled that the motion had passed.

The Grand Secretary asked for the will of the Delegates to address the two other Amendments mentioned in the Advisory Board Report without the benefit of a printed report of the amendment. Past Grand President Robert Lacey, Danneskjold #17 moved to accept both amendments based on the wording and explanation from the Grand Secretary. Seconded by Jeannie Melendez, Sønderjylland #10. For clarity I have included below the two amendments as they should have been presented. Both amendments were Moved and Seconded at the same time but voted on separately.

Danish Society Dania of California and Nevada

ARTICLE VII

LAWS GOVERNING THE GRAND LODGE

As written in the Constitution:

Section 1

The Grand President, during his term of office, shall be entitled to draw on the general fund the amount of SIX HUNDRED and 00/100 DOLLARS (\$600.00) as traveling expenses incurred in visiting the local Branches.

Change to:

Section 1

The Grand President, during his term of office, shall be entitled to draw on the general fund the amount of SIX TWEVE HUNDRED and 00/100 DOLLARS (\$600.00) (\$1,200.00) as traveling expenses incurred in visiting the local Branches.

The results of the vote was 1 Yes and 35 No, The Grand President ruled that proposed Amendment number Three had failed.

Amendment #4 to the Constitution Danish Society Dania of California and Nevada

As written in the Constitution:

Section 2

The Grand Marshal, during his term of office shall be entitled to draw on the General Fund the amount of THREE HUNDRED and 00/100 DOLLARS (\$300.00) as travel expenses incurred in visiting the local Branches.

Change to:

The Grand Marshal, during his term of office shall be entitled to draw on the General Fund the amount of THREE SIX HUNDRED and 00/100 DOLLARS (\$300.00) (\$600.00) as travel expenses incurred in visiting the local Branches.

The results of the vote was 2 Yes and 31 No, The Grand President ruled that proposed Amendment number Four had failed.

Grand President Roger Gearhart called for a Lunch break from 11:50 A.M. till 2:00 P.M.

Grand President Roger Gearhart reconvened the meeting after the Lunch break at 2:00 P.M.

The Grand Marshal collected the password from the new members in attendance.

The Grand President Roger Gearhart requested that the Grand Secretary present the bills in accordance to Article III, Section 10 Paragraph 3 of the Constitution where in it states "each expenditure must be considered individually."

Past Grand President Robert Lacey moved to pay the Grand Secretary \$200.00 per month expense reimbursement. Seconded by Jeannie Melendez, Sønderjylland #10, the motion was adopted.

Grand Secretary Tim Heer moved to pay the Grand Treasurer \$100.00 per month expense reimbursement. Seconded by Rowland Mc Neil, Thyra #9, the motion was adopted.

Grand Secretary Tim Heer moved to pay the Grand Trustee \$1.00 each per year expense reimbursement. Seconded by Anni Champagne, Bornholm #14, and the motion was adopted. The Grand Trustees requested that the minutes show that they had recused themselves from voting due to the significant amount of money involved in the motion

Grand Secretary Tim Heer moved to pay the 2011 Convention Committee \$300.00 for expenses, \$100.00 bowling prize and \$100.00 golf prize for a total \$500.00. Seconded, and the motion was adopted.

Grand Secretary Tim Heer moved to set Funeral Benefit at \$200.00 Seconded by Tom Martin, Danmark #2, and the motion was adopted.

Grand Secretary Tim Heer moved to set the annual per capita tax at \$20.00 per member paid semiannual. Seconded by Mel Lundberg, Valhalla #11, and the motion was adopted.

Grand Secretary Tim Heer moved to pay \$40.00 annual dues to Aldersly. Seconded by Grand Treasurer Gregory Gleeson, Thyra #9, and the motion was adopted.

Grand Secretary Tim Heer moved to donate \$25.00 to the Bethel Lutheran Home in Selma. Seconded by Grand Trustee Peder Hoy, Bornholm #14, and the motion was adopted.

Grand Secretary Tim Heer moved to donate \$25.00 to the Solvang Lutheran Home. Seconded by Anni Champagne, Bornholm #14, and the motion was adopted.

Grand Secretary Tim Heer moved to donate \$25.00 to the Elverhøj Museum of History and Art. Seconded by Tom Martin, Danmark #2, and the motion was adopted.

Grand Secretary Tim Heer moved to donate \$50.00 to the Danish American Historical Society in Fresno. Grand President Roger Gearhart ruled the motion had died for lack of a second.

Grand Secretary Tim Heer moved to donate \$25.00 to the Danish American Historical Society in Fresno per the request of Past Grand President Stanley Kjar and two other Past Presidents of the Danish American Historical Society. Seconded by Rowland Mc Neil, Thyra #9, and the motion was adopted.

Grand Secretary Tim Heer moved to pay for a monthly ad supporting the Grand Lodge and the Locale Branches of Dania in the Bien Newspaper at a cost not to exceed \$500.00 per year. Seconded by Past Grand President Kaj Kristensen, Danmark #2, the vote was 35 yes 7 No; the motion was adopted.

Grand Trustee Bent Olsen informed the delegates that the Danish Capital in the United States, Solvang, will be celebrating their 100 birthday in 2011 and that there was going to be a magazine coming out in the first part of the year and would be looking for advertisement. He was wondering if the Grand Lodge would be interested in placing an ad in the magazine.

Grand Secretary Tim Heer as a Delegate who voted on the prevailing side of the previous motion

moved to bring the motion back to the floor to reconsider the motion in light of this new information. Seconded by Past Grand President Robert Sorensen, Bornholm #14, the vote was 39 yes 2 no; the motion was adopted.

Grand Secretary Tim Heer moved to pay for a monthly add supporting the Grand Lodge and the Locale Branches of Dania in the Bien Newspaper at a cost not to exceed \$500.00 per year. Seconded by Past Grand President Kaj Kristensen, Danmark #2, the vote was 6 yes 34 no; the motion was not adopted.

Grand Secretary Tim Heer moved to pay for an advertisement in the Solvang 100 anniversary Magazine not to exceed \$500.00. Seconded by Past Grand President Robert Sorensen, Bornholm #14, and the motion was adopted.

Jackie Nielsen asked a question about the Grand Lodge Constitution. Grand Secretary moved to be allowed to sell copies of the Constitution at a cost of \$10.00 each. Seconded by Past Grand President Stuart O. Mahler, Thyra #9, and the motion was adopted.

Recess at 3:10 P.M.

After the coffee break we met together with the Members of Dannebrog where we watched an audio/video presentation presented by Erik Jorgensen on behalf of his Son Scott Jorgensen's College work that he is doing in the area of Native Plant Management. Scott has been the recipient of many Scholarships from both Dania and Dannebrog in the past years, and this presentation was a way of saying thank you to both Grand lodges and also showing how our Scholarship moneys are being spent. At the same time Scott also represented all of the recipients and the fine work that they are doing in their chosen field of study. The Presentation concluded with a brief photo slide show highlighting the close connections between the Jorgensen Family and the two Grand Lodges.

Convention reconvened at 3:30 P.M.

Nomination of new Grand Officers

Grand President Roger Gearhart appointed three tellers John Jensen, Danmark #2, Karen Lysmer, Sønderjylland #10 and James Olef Jensen, Danmark #2.

Grand President Roger Gearhart explained that in the case of one nominee that the Grand Secretary is to cast the ballot. In the event of the Grand Secretary nominee, the Grand Treasurer will cast the ballot.

Grand President Roger Gearhart, Danmark #2, dismissed the tellers with thanks.

The Grand Marshal of Dannebrog Judi Heer, Dana #15, requested admission. Once inside she reported that the Dannebrog had voted to place a joint ad in the Solvang magazine and they would contribute \$250.00 towards a joint ad with Dania.

After the Grand Marshal of Dannebrog left the room the Grand President Roger Gearhart instructed the Grand Marshal Kurt Høj to inform the Grand Lodge of Dannebrog that we accept their offer to join with them in placing an ad in the Solvang magazine.

Past Grand President Jim Jorgensen rose to a point of information asking about the status of the 2010-2011 Grand President and Grand Marshal's traveling expense, since it has not been brought up, does it stay as the amount that is in the Constitution?

Grand Marshal Kurt Høj returned and report that he was well received and that Dannebrog was looking forward to the affair.

Grand President Roger Gearhart informed the Grand Marshal of the question that had come up during his absents and then entertained a motion to add to the Constitutional amount of moneys allocated for traveling expenses. Anni Champagne, Bornholm #14, moved to increases the Grand Presidents traveling expenses by \$600.00 making it a total of \$1,200.00 Seconded by Tom Martin, Danmark #2. After a brief debate Grand President Roger Gearhart call for a two minute recess. The Meeting was called back to order and the Grand President reported to the Delegates that during the recess he had caucused with the delegates of Danmark #2 and they had agreed to make a sizeable donation to the Grand Lodge of Dania that would be more than enough funds to cover this added expense. In light of this new information the Grand Secretary withdrew his objection to the motion. The result of the vote was 25 yes and 6 no; the Grand President ruled that the motion was adopted.

Anni Champagne Bornholm #14 moved to increases the Grand Marshal for 2010-2011 traveling expenses by \$300.00 making it a total of \$600.00; seconded by Tom Martin, Danmark #2. The result of the vote was 28 yes and 4 no; the Grand President ruled that the motion was adopted.

Tom Martin, Danmark #2 moved to conduct an open joint Installation of Officers at 2:00 P.M. Saturday. Seconded by Karen Lysmer, Sønderjylland #10, and the motion passed.

Grand President Roger Gearhart directed the Grand Marshal Kurt Høj to inform the Grand Lodge of Dannebrog on our desire to hold an open joint installation. Grand Marshal Kurt Høj requested that the Grand Vice President Lilian Rasmussen and Karen Lysmer, Sønderjylland #10 accompany him to the Dannebrog meeting room. The request was granted. On their return to our meeting, Grand Vice President Lilian Rasmussen reported that Dannebrog accepted our invitation.

The Grand Secretary read the Resolution Committee's report pertaining to the Queen's 70th Birthday per the Grand Presidents request. (**See addendum**)

Grand Trustee Bent Olsen moved to allow Jack Frederickson and friend of Grand President-elect Lilian Rasmussen admittance to the Saturday meeting to hear Lilian's report. Seconded by Karen Lysmer, Sønderjylland #10, and the motion passed.

Mel Lundberg, Valhalla #11, moved to adjourn until 10:30 A.M. Saturday Morning. Seconded by Grand Treasurer Gregory Gleeson, and the motion passed.

SATURDAY April 17, 2010

Convention was called back to order at 10:30 A.M. by Grand President Roger Gearhart. The password was taken up by the Grand Marshal and Grand Vice Marshal 10 Grand Officers, 26 Delegates and 15 Past Grand Presidents responded to roll call

Pete Olsen, Valdemar #12, reminded the delegates that they would be hosting next year convention right here at John Ascuaga's Nugget, Sparks Nevada on April 14-16, 2011

Grand Secretary Tim Heer moved that the 2010-2011 Grand President create a committee to review and update the Grand lodge application for Membership, and submit it to the Executive Committee for approval. Seconded by Jeannie Melendez, Sønderjylland #10, and the motion passed.

Resolution Committee report: the Resolutions were read by the members of the Committee Tom Martin, Danmark #2, Rowland McNeil, Thyra#9, and Christian Nielsen, Valhalla #11. Past Grand President Kaj Kristensen, Denmark #2, moved to accept the repot Seconded by Jim Gearhart, Danmark #2. The report was accepted. (**See addendum**)

Report of the Law Committee: Grand Trustee George Cumming Jr. reported that they had nothing to report. (**See addendum**)

Fashion Report: Rowland McNeil, Thyra#9, reported that the last of the inventory has been sold and handed over a check for \$50.00

Jackie Nielsen, Dannevang #7, asked if they could give their old Danish books to a Museum or do they have to give them to the history committee? Report of the Tax Committee

Graham Sorensen and Roger Gearhart attended the "FREE Tax Seminar for Nonprofit and Faith-Based Organizations" held in Elk Grove on May 19, 2009. Faith-based organizations and churches are classified as 501-(C)-3. Some Fraternal organizations, such as the Elks, are 501-(C)-10. We are a 501-(C)-8 because of the death benefits and sick benefits Dania and our branches offer. There is some overlap to the 501-(C)-3 but not much. A

consequence of being a 501-(C)-8 is that we are required to use our funds for members. We do that as a matter of course in our sick benefits, funeral benefits, our Old Age Fund expenses, scholarships, Grand Officer expenses, and by local Branches subsidizing local Branch functions.

There were presentations dealing with real and personal property and employee issues. Inasmuch as we have no employees, we do not have to worry about health insurance, disability insurance, unemployment, etc. Nor do we have any real estate. We do have personal property in the form of regalia, badges, flags, and food preparation equipment but no office machines, computers, printers, telephones----really, we have nothing significant. For instance, try to sell our regalia, badges and flags----it is doubtful that we could get more than a few hundred dollars. We can conclude that we have no personal property worthy of reporting.

We talked privately to many of the speakers from whom we learned some interesting facts. The Board of Equalization, the Franchise Tax Board and the IRS see mostly (C) -3 type problems----the 501-(C)-8 organizations are regarded as insignificant and are generally ignored unless specific issues are raised by the organizations. This attitude extends to enforcement as well----the 501-(C)-8 are "small potatoes" and we, Dania, are probably well below their threshold in all regards.

The single issue that could cause problems would be raffles. However, the profits from raffles at conventions are always used to offset our convention expenses. In any event, the total tax would be no more than \$200 or so---hardly worth consideration. The best advice for Dania would be to keep a low profile and to keep filing the form 990 in a timely manner (thanks Tim). For raffles, don't advertise on the internet, keep it low key and don't publicize the big winners.

A reminder to all Branches that the sole contact with the taxing agencies should be only through our Grand Secretary. Any information sent to a local branch should be forwarded to Tim for him to handle.
