Grand President Lilian Rasmussen, Sønderjylland #10, called the convention to order at 9:00 A.M. The password was taken by Grand Marshal Johanna Gade, Bornholm #14, and Grand Vice Marshal Mel Lundberg, Valhalla #11. After the password was obtained the Grand President called for the opening sign.

The assembly then rose to recite the pledge of allegiance to the flag of the United States of America followed by the singing of the Danish National Anthem, led by Past Grand President Kaj Kristensen, Danmark #2.

Grand President Lilian Rasmussen, Sønderjylland #10, then declared a moment of silence for those departed members this past year as Grand Marshal Johanna Gade, Bornholm #14, draped the Charter.

Grand President Lilian Rasmussen proclaimed the 131st Dania Convention in session with full powers and authority to act. Grand President Lilian Rasmussen introduced the Dania members who represented the Convention Committee from Valdemar #12, Carl Christiansen, Erik Hansen, Pete Olsen and Baxter Swaffer, who welcomed the Grand Officers and delegates to the 131st convention

Grand President Lilian Rasmussen instructed The Grand Marshal Johanna Gade to escort Past Grand President Mr. Peder Hoy, Bornholm #14, to the chair on her right to act as her advisor during the Convention.

Grand President Lilian Rasmussen asked Grand Secretary to read the minutes from the close of the 130th convention. Grand President Lilian Rasmussen, asking for any errors or addition. Past Grand President Jim Jorgensen, Bornholm #14 reported the omission of the passing of his Brother in-law Chris Burton on November 27, 2010. Moved by Jeannie Melendez, Sønderjylland #10 to approve the minutes as corrected. It was seconded By Christian Nielsen, Valhalla #11 and Passed.

Grand President Lilian Rasmussen asked Grand Secretary to call the roll, 10 Grand Officers, 28 Delegates and 16 Past Grand Presidents responded to roll call. See addendum for the complete Roll Call result

Grand President Lilian Rasmussen turned the meeting over to Grand Vice President Kurt Høj. The Grand President read her report. (**see addendum**). It was moved by Grand Past President Roger Gearhart, that we accept the report of the Grand President. Seconded by Past Grand President Gunner R. Nielsen, Thor #5, and passed. The Grand Vice President Kurt Høj after ruling on the motion returned the Gavel to Grand President Lilian Rasmussen.

Report of the Executive Committee: The minutes of the two Meetings held on August 7, 2010 and March 19, 2011 were read by the Grand Secretary. It was moved by Past Grand President Kaj Kristensen, Danmark #2, to accept the report. Seconded by Jackie Nielsen, Dannevang #7 and carried. **See addendum.**

Grand Secretary's report: The Grand Marshal and Grand Vice Marshal handed out the reports of the Grand Secretary, Grand Treasurer and The Grand Trustees. While the reports were being passed out, the Grand Secretary verbally reported on the request made last year regarding the financial burden of the funeral benefit. The calculations showed that the total cost would be \$81,713.00 and the average Benefit would be \$155.05. This was not included in the written report due to the difficulty of auditing the calculation. Grand Past President Roger Gearhart asked if a pin inventory could be included in next year's report. After the Grand Secretary's annual report was reviewed and The Grand Secretary then called the Delegates attention to the itemized reports of the Branches on Membership, Assets, Receipts, and Disbursements for review. Grand Trustee George Cumming Jr, Thyra #9, moved to accept the report. Seconded by

Jeannie Melendez, Sønderjylland #10, and carried. (See addendum)

Recess at 10:00 A.M. Convention reconvened at 10:35 A.M. The Grand Marshal collected the password from the new members in attendance.

Grand Treasurer's Report was presented by Grand Treasurer Gregory Gleeson, for reviewed. Past Grand President Kaj Kristensen, Danmark #2, moved to accept the report, seconded by Past Grand President Robert Sorensen, Bornholm #14, and carried. (**See addendum**)

Grand Trustees' Report was presented by the Grand Secretary, Grand Trustee George Cumming Jr. added more information about the cash account and that it may be too high and some of that cash could be transferred to an interest account. After review, Past Grand President Kaj Kristensen, Danmark #2, moved to accept the report. Seconded by Karen Lysmer, Sønderjylland #10, and carried. (**See addendum.**)

NEW BUSINESS

Grand President Lilian Rasmussen asked to have the Resolution of Change handed out to the Officers, Delegates and Past Grand Presidents for consideration, along with the Old Age Fund report.

John Schueber addressed the Grand president with a request to have a traveling Microphone so that the Delegates could hear the question and comments from everyone.

The Grand Secretary presented the annual reports of the Old Age Fund for the information of the membership.

The Grand Secretary gave a report on changes made to the Diana/Dannebrog Old Age fund Bylaws, The Grand Secretary moved for the acceptance of the changes and to incorporate it into the Dania Constitution, seconded by Grand Vice Marshal Mel Lundberg, Valhalla No. 11, and carried.

The Grand Secretary directed the Members to The Resolution of Change by reading it to those in attendance, (**See addendum**). After Presenting the Resolution of Change the Grand Secretary asked if this would require a change to our constitution. Grand Past Grand President Roger Gearhart moved to accept the resolution. Seconded by Past Grand President Stuart O. Mahler, Thyra #9, and the vote was Yes 25 No 9 the Grand President declared that the motion carried.

The Grand Secretary Moved that the Resolution be sent to the Law Committee to determine if a change to our Constitution is required, seconded by James Olef Jensen, Danmark #2, and passed

The Grand President Lilian Rasmussen requested that the Grand Secretary present the bills individually.

Grand Secretary Tim Heer moved to pay \$40.00 annual dues to Aldersly. Seconded by Grand Past President Roger Gearhart, Danmark #2 and the motion was adopted.

Grand Secretary Tim Heer moved to donate \$25.00 to the Solvang Lutheran Home. Seconded by Past Grand President, Kaj Kristensen, Danmark #2, and the motion was adopted.

Grand Secretary Tim Heer moved to donate \$25.00 to the Elverhøj Museum of History and Art. Seconded by Rowland McNeil, Thyra #9, and the motion was adopted.

Grand Secretary Tim Heer moved to donate \$25.00 to the Danish American Historical Society in Fresno. Seconded by John Jensen, Danmark #2, and the motion was adopted.

Grand Secretary Tim Heer moved to pay the Grand Trustee \$1.00 each per year expense reimbursement. Seconded by Grand Treasurer Gregory Gleeson, Thyra #9, and the motion was

adopted

Grand Secretary Tim Heer moved to pay the 2012 Convention Committee \$300.00 for expenses, \$100.00 bowling prize and \$100.00 golf prize for a total \$500.00. Seconded by Past grand President Kaj Kistensen, Danmark #2, and the motion was adopted

Grand Secretary Tim Heer moved to pay the Grand Treasurer \$100.00 per month expense reimbursement. Seconded by Grand Trustee Thomas Martin, Danmark #2, the motion was adopted.

Grand Secretary Tim Heer moved to set Funeral Benefit at \$200.00, seconded by Grand Past President Roger Gearhart, Danmark #2, and the motion was adopted.

Grand Secretary Tim Heer moved to set the annual per capita tax at \$20.00 per member annually, paid semiannual, except for Branches who have demonstrated financial difficulty the tax be set at \$1.00 per member paid semiannual. Seconded by Past Grand President Stuart O Mahler, Grand Secretary. Tim Heer moved to Table the Motion until after Lunch, seconded by Grand Treasurer Gregory Gleeson, Thyra #9, The Grand President declared the Motion Tabled.

Grand President Lilian Rasmussen declared the convention to be at recess for Lunch and to reconvene at 2:00 P.M.

Grand President Lilian Rasmussen reconvened the meeting after the Lunch break at 2:00 P.M.

The Grand Marshal collected the password from the new members in attendance.

Grand Secretary Tim Heer moved to bring the tabled motion back to the floor for consideration. Seconded by Past Grand President Stuart O Mahler and the Grand Secretary restated the Tabled Motion for the new members. The Motion failed

Grand Secretary Tim Heer moved to set the annual per capita tax at \$20.00 per member annually to be paid semiannually. Seconded by Past Grand President Stuart O Mahler and the motion passed 30 yes and 7 no.

Grand Secretary Tim Heer moved to increases the Grand Presidents traveling expenses by \$600.00 over the current Constructional amount of \$600.00 to a total of \$1,200.00. Seconded by Grand Past President Roger Gearhart, Danmark #2, and the motion was adopted with 30 Yes and 4 No votes

Grand Secretary Tim Heer moved to increases the Grand Marshal traveling expenses by \$300.00 over the current Constructional amount of \$300.00 to a total of \$600.00, seconded by Grand Past Trustee Thomas Martin, Danmark #2, and the motion was adopted with 37 Yes and 4 No votes

Past Grand President Peder Hoy, Bornholm #14, moved to pay the Grand Secretary \$200.00 per month expense reimbursement, seconded by Grand Past President Roger Gearhart, Danmark #2, and the motion was adopted with 37 Yes and 4 No votes

Grand Secretary Tim Heer moved to continue the payments in support of our web site not to exceed \$300.00. Seconded by Grand Treasurer Gregory Gleeson, Thyra #9, and the motion was adopted with 32 Yes and 0 No votes

Jim Jensen, Danmark #2 announced that Danmark #2 pledges to match all other Branches donations to the Grand Lodge General fund up to \$5,000.00 between the end of Convention and May 16, 2011. This was announced as a challenge to the other Branches.

The Grand Marshal collected the password from the new members in attendance.

Grand Trustee Thomas Martin, Danmark #2, declined the nomination for Grand Vice Marshal and Steen Skjellerup, Thor #5, also declined the nomination for Grand Vice Marshal. The Grand President asked the Grand Secretary to cast the ballot for Robert Schall, Hejmdal #4, for Vice Marshal.

Grand Trustee #3 George A Cumming Jr. Thyra #9

Grand President Lilian Rasmussen, Sønderjylland #10, dismissed the tellers with thanks.

Grand Past President Roger Gearhart, Danmark #2 presented Grand President Lilian Rasmussen with a cup as a reminder of her first Past Grand President's Luncheon.

Grand Treasurer Gregory Gleeson moved to adjourn until 10:00 A.M. Saturday Morning. Seconded and after some discussion Grand Treasurer Gregory Gleeson withdrew his motion and

Grand President Lilian Rasmussen adjourned the meeting until 9:00 A.M. Saturday Morning..

SATURDAY April 17, 2011

Convention was called back to order at 9:00 A.M. by Grand President Lilian Rasmussen. The password was taken up by the Grand Marshal and Grand Vice Marshal. 10 Grand Officers, 29 Delegates and 15 Past Grand Presidents responded to roll call

The Grand President asked the Grand Marshal to escort her advisor Past Grand President Peder Hoy to her station

GOOD OF THE ORDER

Jackie Nielsen, Dannevang #7, Move to impose a five dollar fine on anyone who receives a phone call during an open meeting at Grand Lodge with the proceeds going to the Old Age Fund. Seconded by Past Grand President Robert Lacey, Danneskjold #17 then Bent Olsen, Hejls Minde #23, moved to amend the motion by changing the fine from \$5.00 to \$10.00. Seconded by Past Grand President Robert Sorensen, Bornholm #14, and the motion was adopted. Yes 26 No 6

Past Grand President Robert Lacey moved that all cell phones are turned off as the members enter the meeting room. This motion was never seconded and no action was taken.

Past Grand President Roger Gearhart reported that the Danish Encyclopedia will be on loan to the Ferndale Lodge for an undetermined time. He also reported on the activities of a new group called Gathering.

John Schueber, Bornholm #14, moved that the incoming Grand President establish at least six months before the next Convention a Nominating Committee consisting of a Grand Officer, a Past Grand President and a Member at large. The Nominating Committee would come up with one to three names for each open Office a month before convention to be posted in the Bulletin so the membership would be able to know in advance who was planning on running for which Office. Francis Sweet, Valhalla #11, seconded the motion and the lengthy speech, the motion was adopted. Yes 35 No 1

Richard Hansen, Thor #5, reported on Stanley Kjar and it was all good news.

Francis Sweet, Valhalla #11, invited the Grand Officers and Delegates to Ferndale for the 2014 convention. It was moved by Past Grand President Jim Jorgensen, Bornholm #14, to accept the invitation from Valhalla. It was seconded and passed. The Delegates were reminded that the Convention date of 2013 is still open. Yes 38 No 1 (Francis Sweet)

The Grand President asked the Grand Marshal to escort Grand President elect Kurt Høj of Hejls Minde #23, Solvang to podium where Grand President Lilian Rasmussen asked the Grand President-elect to address the Grand Officers, Delegates and Members. The first thing was to apologize for being tardy to yesterday's meeting which was accepted by Grand President Lilian Rasmussen. He commended the job that Lilian did as Grand President

Grand President-elect Kurt Høj gave a thank you speech and pointed out that sometimes his name is spelled KRUT and in Danish KRUT means ammunition so he wants us all to know that he is loaded and ready to go!

He then introduced his advisor Past Grand President Peder Hoy and his password. The Grand Marshal then escorted the Grand President Elect back to his station.

Bent Olsen gave a rundown of the menu items for the 2012 convention and it is going to be 100% Danish meals for all of the banquets. This news was very well received by everyone in attendance.

At 10:15 the Grand President Lilian Rasmussen declared a fifteen minute coffee break.

Grand President Lilian Rasmussen called the convention back to order at 10:30 A.M.

Resolution Committee report: the Resolutions were read by the members of the Committee Karen Lysmer Sønderjylland #10, Carl Christiansen, Valdemar #12, John Jensen, Danmark #2. Past Grand President Kaj Kristensen, Denmark #2, moved to accept the report, seconded. The report was accepted. (See addendum)

Grand Treasurer Gregory Gleeson paid all of the Grand Trustees their annual salary in cash out of his pocket.

The Grand Marshal Johanna Gade announced that all of the members of Dannebrog were without the door and asked to come in. Grand President Lilian Rasmussen invited them in. After all of our visitors were in the room and the Grand Vice Marshal announced that the doors were closed, the Grand President welcomed the members of Dannebrog and then asked the Grand Marshal to escort the Grand President Elect Kurt Høj to the front and announced that we have assembled for a special event and explained that she wanted both Grand Lodges together and had invited Grand Vice President Kurt Høj to preside for the presentation of the Dania Member of the year to Francis Sweet. It was Grand President Lilian Rasmussen intent to invite all of the members of Dannebrog so that they can have a part in this special moment for Francis,

the award even though he had not yet been installed as Grand President at this time. It was done in this manner because it was learned that the Sweets were not staying for the Saturday night dinner and this was the only time that was available to make the presentation.

Grand President Lilian Rasmussen informed everyone about the fact that at next year's convention in Solvang that Hejls Minde #23 will hold their annual installation of Officers on the Friday night of Convention, and that the 2014 Convention will be held in Ferndale.

Report of the Law Committee: Grand Trustee George Cumming Jr., Thyra #9, reported that two items were sent to the Law Committee. One item being the qualification of a member to be nominated for office. Although it was no longer an issue, he did report that the opinion expressed during the meeting was consistent with our Constitution. The second issue having to do with the Resolution of Change that was approved on Friday, and the Committee found no conflict with our Constitution, and would not require any amendment or changes to implement the suggested options as to how to hold an Installation. The local Branches are free to hold their installations as they see fit.

Grand Vice Marshal Mel Lundberg, Valhalla #11, moved to reconsider Resolution of Change that was approved yesterday, Mel confirmed that he had voted on the prevailing side. The Motion to reconsider was seconded by Rowland McNeil, Thyra #9, the motion passed. 18 Yes 12 No. Past Grand President Robert Lacey withdrew his Resolution of Change for consideration; his request was approved by the Grand President.

Grand Secretary Tim Heer moved to accept the report of the Law Committee. Past Grand President Roger Gearhart seconded and the motion was approved 41 Yes 0 No

Grand President Lilian Rasmussen declared the 131st annual convention closed at 11:20 A.M. At 2:00PM Dania and Dannebrog participated in a joint installation of Grand Officers.

Report of the Grand President, April 15, 2011.

Past Grand Officers, Grand Officers, Delegates and Members of the Danish Society Dania, of California and Nevada.

Serving you, as Grand President for the past 12 month's, has indeed been an honor.

I would again like to thank Thyra #9 and Danneskjold #17, for co-hosting together with my home Lodge,
Sønderjylland #10, at last years convention. Thanks to Grand Trustee George Cumming Jr. and to Past Grand
President James Jørgensen, for being the *chair team* responsible for golf and bowling. To Past Grand President
John Johansen, thanks for helping creating the very nice *Convention Program*. The Nugget Hotel, in Sparks
Nevada, is a wonderful place to hold Conventions. Here we are again, for a second year in a row.

Going back to December 7, 1991, DANIA constitution was amended to allow people of non Danish heritage and for woman to become members of Dania. This was a remarkable step.

My home lodge, in Petaluma, was the very first Lodge to install 13 ladies. Now, 20 years later, sorry to say, we are only 5 left of the 13. Two of us are present, Secretary Jeannie Melendez and myself.

Little did I ever dream when I joined, that one day, I should be the Grand President of the Danish Society DANIA of California and Nevada?

In August of 1997 I lost my husband of 35 years due to cancer. The abundance of support and friendship, my children and I received, from what I call 'My Dania and Dannebrog family', I never will forget.

I owe big thanks to many of you here, that supported me then, gave me strength to go on and guided me to be, who I am today. That was when I decided, it was time to 'give back'.

I have had the honor of being Sønderjylland #10's President for 3 years, Secretary for 11 years and their Treasurer, now going on my 16th year.

At the 127th Convention, held in Fresno 2007, history was made again. Saturday April 14, 2007, I was elected and installed as the first lady, to start a journey through the *chairs in Dania*.

My work as Grand Vice Marshal was easy, with the supervision of our, always happy, Past Grand President, Stanley Kjar. When Stan introduced his Officers at installations, that first woman Dania Officer, was left out 3-4 times. He has over and over again, asked for forgiveness and it's been granted.

Stepping up to the Grand Marshal's position, required doing a bit of homework. The wording for the 'Combined Ritual for the installation of local Officers' and the 'marching pattern', was still young and the latter, needed some attention.

Past Grand President, John Champagne, was the perfect person to do just that.

He made sure that Dannebrog's Grand Marshal Collen Cave and I, put the *left foot first* and that rounding of corners, became square. I think we did well, thanks to Mr. John. He certainly knew how to march and give directions.

Friday April 16th of 2010, one very short year ago, Grand Trustee Mr. George Cumming Jr., introduced me as "Petaluma's glue" and nominated me. I wish to, again express my sincere thanks for the confidence you gave me.

Installation took place on April 17, 2010 at the 130th Convention at the Nugget Hotel in Sparks, Nevada.

It was a very special time for me, having my son Hans-Erik Rasmussen and my friend of 55 years, Jack Fredriksson present. Jack is very dedicated and active in 'the Odd Fellows Lodge' in Sweden. They are 'toying' with the possibility, of integrating men and woman. Now, he has seen proof, it has been done here and that it has worked very well. Hope you agree.

During my term as your Grand President, I have been presiding at every Lodge installation, and making some official visits. Attended some lodges for their general meeting, and some lodges, I had pleasure in visiting more than once.

I would like to thank all the branches for their dedication to our Society Dania and for all the hard work in preparing for meetings and installations. Decorating, preparing delicious food and of course, for the time we spent together at the 'attitude adjustment hours', with Mr. Carlsberg and Mr. Aalborg.'

I have always been received with honor and wonderful hospitality. It is very interesting to see and hear, how and what, the various Lodges do for their members.

On May 7, 2010, Grand Officers met in Reno, Nevada for the first installation, installing the officers of Valdemar #12. Admit I was a little tense, but with the very friendly and relaxed Reno group, all went well.

May 13, 2010, I attended Thyra #9's general meeting, with President George Cumming presiding. Added to his attire was a chef's apron. He was also in charge of a delicious meal. During the dinner, I had a great conversation with the Dania scholarship recipient, Scott Jørgensen. I found him to be a wonderful nice young man with a promising future.

The absolute *HIGHLITE* during the visit to Modesto, was the honor I had to present a 50-year pin, to our friend and Past President Peter Hoy.

August 14, 2010, Installation time at Sønderjylland #10, Petaluma. Installing my home lodge's Officers, was very special. Festivities held at beautiful Kastania Park, with Karen Lysmer as the Past President for 3 1/2 years and Finn Kjar being installed as our President. Having Lise van der Beck catering the beautiful luncheon and her brother, Past Grand President Niels Walter Hansen, visiting all the way from Pedrolia, was wonderful. Twelve Dania Grand Officers, seven Dannebrog Officers and 38 additional friends and members was there as well. Many dressed in red and white. It was a day to remember.

September 4, 2010, Valhalla #11, Ferndale had their installation scheduled.
