Grand President, Bob Schall, Hejmdal #4, instructed the Grand Officers to take their respective Stations and the Grand Vice Marshal Daniel Joensen, Danmark #2, to close the door.

The password was taken by Grand Marshal, Steen Skjellerup, Thor #5 and Grand Vice Marshal Daniel Joensen, Danmark #2. After the password was, obtained the Grand President called for the opening sign.

Grand President, Bob Schall, asked Grand Secretary, Tim Heer, to please call the roll, 10 Grand Officers, 33 Delegates and 16 Past Grand Presidents responded to roll call. See addendum for the complete Roll Call result.

The assembly then rose to recite the pledge of allegiance to the flag of the United States of America followed by the singing of Der er et yndigt land, led by three of Dania's lady delegates. Grand President, Bob Schall, asked the Grand Marshal, Steen Skjellerup, to drape the charter in memory of our departed members.

Grand President, Bob Schall, Welcomed everyone to the convention and then proclaimed the 135th Annual Convention of The Danish Society, Dania of California and Nevada in session with full powers and authority to act.

Grand President, Bob Schall, instructed Grand Marshal, Steen Skjellerup to escort his advisor Past Grand President, Johanne Rasmussen Gade, Bornholm #14, to the chair on his right to act as his advisor during the Convention.

Grand President, Bob Schall, asked Grand Secretary, Tim Heer, to read the minutes from the close of the 134th convention to the opining of this convention. Grand Secretary requested that the minutes be postponed until such that they could be located. The Grand President granted the request.

Report of the Grand President: Grand President, Bob Schall, turned the meeting over to Grand Vice President, Thomas Martin, and asked the Grand Marshal to take the gavel to his station. The Grand President read his report. (**see addendum**). It was moved by Past Grand President Roger Gearhart, Danmark #2, that we accept the report of the Grand President, seconded by Grand Trustee, John Schueber, Bornholm #14. The Grand Vice President, Thomas Martin, ruled that the motion was approved, and then asked the Grand Marshal returned the gavel to Grand President.

Minutes of the Executive Committee: The minutes of the meeting held on August 30, 2014, February 7, 2015 and March 21, 2015 were read by the Grand Secretary. It was moved by Grand Past President Mel Lundberg, Valhalla #11, to accept the reports. Seconded by Grand Vice President, Thomas Martin, Danmark #2, and carried. (See addendum.)

Grand Secretary's report: After the Grand Marshal and Grand Vice Marshal handed out the reports of the Grand Secretary, Grand Treasurer and The Grand Trustees. They then passed out the reports of the Senior Assistance fund. The Grand Secretary's annual report was reviewed.

Grand President, Bob Schall, called for a brief recess to allow the Mayor of Fortuna, Sue Long, to bid us welcome. She was escorted to the alter and introduced by the Grand Vice Marshal, then escorted to the podium where She gave a welcoming address. Her welcome was warmly received by the Grand President and Delegates. After she was escorted out of the meeting room the Grand President call the meeting back to order.

Recess at 10:05 A.M. Convention reconvened at 10:30 A.M.

Grand President, Bob Schall, asked for all those who were not in the morning session to stand, there being no one standing, he reconvened the meeting.

The Grand Secretary then called the Delegates attention to the itemized reports of the Branches on Membership,

Assets, Receipts, and Disbursements for review. Following an explanation of every line item found on the report, and attempting to address every question of the Delegates, it was moved by Past Grand President, Peder Hoy, Bornholm #14, and seconded by Past Grand President, Robert Lacey, Danneskjold #17 to accept the report of the Grand Secretary, and the motion was adopted. (**See addendum**)

Grand Treasurer's Report: Grand Treasurer, Gregory Gleeson, presented the Grand Treasurer's report for review. Grand Past President Mel Lundberg, Valhalla #11, moved to accept the report, seconded by John Jensen, Danmark #2, and the motion was adopted. (**See addendum**)

Grand Trustees' Report: Grand Trustee #1, James Olef Jensen, Danmark #2, read the report. After review, Past Grand President, Tim Heer, Freja #6, moved to accept the report. Seconded by Grand Past President Mel Lundberg, Valhalla #11, and the motion was adopted. (**See addendum.**)

Grand Secretary, Tim Heer, Freja #6, moved to remove the beginning and ending balances of the Grand Treasurer's General Fund checking account, from future Grand Trustee's reports. The Grand President allowed the motion at this time, and it was seconded by Grand Trustee, John Schueber, Bornholm #14. The motion was adopted.

Grand President, Bob Schall, asked the Grand Secretary to read the minutes from the close of the 133rd convention to the opening of this convention. Grand President, Bob Schall, asked if there were any errors or addition. Past Grand President, Johanne Rasmussen Gade, Bornholm #14, reported that William Gaedtke was initiated on March 20, 2015, Jackie Nielsen, Dannevang #7, asked why the report only showed one new member for Dannevang #7 while the Grand Secretary's report showed five. It was pointed out by the Grand Vice Marshal, Daniel Joensen, that it may be the Grand Secretary's report is based on a calendar year and the convention minutes are from convention to convention. (It was latter determined, by looking at last year's report, that in deed this was the case. There were four Members initiated on February 22, 2014 and was reported last year.) The Grand Secretary apologized for the possibility of any information that he may have miss read and confirmed that the member that was suspended from Danmark #2 on June 11, 2015 was not Kaj Kristensen but Tage Kristensen and that Danneskjold's Branch number is 17 and not 27. There being no further correction or omissions Grand Past President Mel Lundberg, Valhalla #11, moved to accept the minutes as corrected, Seconded by Past Grand President, Kaj Kristensen, Danmark #2. This motion was adopted.

History Committee Report: Past Grand President Roger Gearhart gave the report. Roger reported a new addition of a Dania Pin from 1906 and explained it's history. He explained the collection of his Books that were on the display table from his personal collection, which also had information on Grand Marshal, Steen Skjellerup's family. After the report was read, it was moved by Past Grand President Robert Lacey, Danneskjold #17, to accept the report. Seconded by Francis Sweet, Valhalla #11, the motion was accepted. (**See addendum**)

Report from the Advisory Committee: Grand President, Robert Lacey, Danneskjold #17, reported that there was no report.

Grand Marshal, Steen Skjellerup, gave a report on what he was able to find out about his family history in Past Grand President, Roger Gearhart's, Family history book.

Report of the Camping Committee: Grand Treasurer, Greg Gleeson, reported on the Camping activities both in the past and future campouts. Moved by Grand Vice President, Thomas Martin, to accept the report, seconded by John Jensen, Danmark #2, and the motion was accepted.

Grand President, Bob Schall, declared a Lunch recess at 11:50 P.M. Convention to reconvene at 1:30 P.M.

Grand President, Bob Schall, asked for all those who were not in the morning session to stand, there being no one standing he reconvened the meeting.

Report of the Web committee: Past Grand President, John Johansen, Bornholm #14, presented information regarding the current website.

After the report the Delegates enjoyed a lengthy debate regarding a Password protected area of the website. Past Grand President, Roger Gearhart, moved to set the issue aside until such appropriate time that it can be discussed by experts. Past Grand President, Peder Hoy, seconded the motion. The motion was adopted.

John Jensen, Danmark #2, moved to accept the Website report, seconded by Past Grand President, Peder Hoy, Bornholm #14. The motion was adopted.

Membership Committee Report: John Jensen, Danmark #2, read the report, Moved by Grand Vice President, Thomas Martin, Danmark #2, Seconded by Jackie Nielsen, Dannevang #7, the report was adopted. (**See addendum**)

Report of the Nominating committee: Presented by Past Grand President, Peter Hoy, Bornholm #14, announced the name of Grand Trustee, John Schueber, Bornholm #14, as a nominee for the office of Grand Vice Marshal, and Grand Past President, Mel Lundberg, Valhalla #11 for the Office of Grand Trustee.

NEW BUSINESS

Grand President, Bob Schall asked the Grand Secretary to present the bills. Grand Secretary, Tim Heer, requested the assistance of Grand Marshal, Steen Skjellerup, to second all bill that are presented in the hopes of speeding up the process

Grand Secretary, Tim Heer, Freja #6 moved to set the Funeral Benefit at \$200.00. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand Secretary, Tim Heer, Freja #6 moved to set the annual per capita tax at \$20.00 per member to be paid semiannually. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand Secretary Tim Heer moved to donate \$25.00 to the Danish American Historical Society in Fresno. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand Secretary Tim Heer moved to donate \$25.00 to the Elverhøj Museum of History and Art. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand Secretary Tim Heer moved to pay \$40.00 annual dues to Aldersly. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted

Grand Secretary Tim Heer moved to donate \$25.00 to the Bethel Lutheran Home Selma. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand Secretary Tim Heer moved to donate \$50.00 to the Solvang Lutheran Home. Seconded Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand Secretary Tim Heer moved to pay the 2015 Convention Committee \$100.00 golf prize. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand Secretary Tim Heer moved to pay the (2015) Convention Committee \$300.00 for expenses, seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand Secretary Tim Heer moved to increase the Grand Presidents traveling expenses by \$600.00 over the current Constitutional amount of \$600.00 to a total of \$1,200.00, to be paid monthly. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand Secretary Tim Heer moved to increase the Grand Marshal traveling expenses by \$300.00 over the current Constitutional amount of \$300.00 to a total of \$600.00, to be paid monthly. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand Secretary Tim Heer moved to pay the Grand Trustee \$1.00 each per year expense reimbursement to be paid in cash. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand Secretary Tim Heer moved to pay the Grand Treasurer \$100.00 per month expense reimbursement. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, the motion was adopted

Grand Treasurer Gregory Gleeson moved to pay the Grand Secretary \$200.00 per month expense reimbursement. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, the motion was adopted

Grand Secretary Tim Heer moved to continue the payments in support of our web site not to exceed \$300.00. Seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand Treasurer Gregory Gleeson moved to pay the Grand Secretary/Newsletter Publisher, \$100.00 per month expense reimbursement for the printing of the Monthly Newsletter to be revaluated and adjusted if necessary at every convention.

Grand Secretary Tim Heer moved to continue and renew our Liability Group Insurance, Seconded by Grand Marshal, Steen Skjellerup, Thor #5, and the motion was adopted.

Grand President, Bob Schall, declared a recess at 3:00 P.M. Convention to reconvene at 3:15 P.M.

Grand President, Bob Schall, announced that a room key had been found and if not clamed would be turned over to the Hotel.

Grand President, Bob Schall, Announced that Dannebrog had closed for the day but he would like to be able to address one more piece of business taking our recess for the rest of the day. The Grand President called on the Grand Vice President, Tom Martin, to take over the meeting and directed the Grand Marshal to take the gavel to the Grand Vice Presidents station. The Grand Vice President, Tom Martin, recognized the Grand President, Bob Schall. He spoke on the work that had been done by the Executive Committee during the year on revising the Joint Combined Ritual. The Grand President, Bob Schall, moved to turn this revised ritual over to the Law Committee for their consideration, examination and come back tomorrow with their recommendation. John Jensen, Danmark #2, seconded the motions. The Grand Vice President, Tom Martin called for the vote and declared the motion adopted. At this time the Grand Vice President turn the meeting back over to the Grand President, and directed the Grand Marshal to take the gavel back to the Grand President.

Grand Secretary, Tim Heer, moved that the proposed bylaw change to the Old Age Fund be adopted with the stipulation that if Dannebrog approved a change that was different to what this motions states that we would reconsider this motion.

The Grand President asked the Grand Secretary to read a proposed Hold Harmless Form for the information of the Delegates for latter consideration. The Grand President declared the issue be set aside for Saturday's meeting.

Grand Vice Marshal announced that we had a delegation from Dannebrog who were wishing to be admitted. The Grand President welcomed in the Law Committee of Dannebrog who had made some proposed changes to

the Ritual and recommended that we give this version to our Law Committee, and the Grand President so ordered.

The Grand President announced to the Grand Officers that there would be a practice for installation follow the close of this meeting.

Grand President, Bob Schall declared a recess until 9:30 Saturday Morning.

SATURDAY April 12, 2013

Convention was called back to order at 9:30 A.M. Grand President, Bob Schall, Hejmdal #4, instructed the Grand Officers to take their respective Stations and the Grand Vice Marshal, Daniel Joensen, Danmark #2, to close the door.

The password was taken up by the Grand Marshal, Steen Skjellerup and Grand Vice Marshal, Daniel Joensen. The Opening sign was given.

Grand President, Bob Schall, asked the Grand Secretary to call the roll call of Grand Officers, Delegates and Past Grand Officers. 10 Grand Officers, 33 Delegates and 16 Past Grand Presidents responded to roll call. The assembly then rose to recite the pledge of allegiance to the flag of the United States of America followed by the singing of Der er et yndigt land, led by Past Grand Vice Marshal, Daniel Joensen, Danmark #2 and Uffa Hellsten, Danmark #2.

The Grand President asked the Law Committee to give their report, Past Grand President, Roger Gearhart, gave the report of the Law Committee noting that it is not yet complete At the conclusion of the report the Grand President asked the Grand Marshal to please escort the Law Committee to the Grand Lodge of Dannebrog to present them with our review of the ritual.

The Grand President recognized the Grand Secretary, who thanked the Branches and Individuals for their generosity in the amount donated last year and reminded the Delegates that without the suggested change in the per capita tax there is still a need for donation this year to be able to maintain our high level of operation.

John Jensen, Danmark #2, announced that Danmark #2 will donate \$1,000.00 and match up to \$2,000.00 of donation from other Branches. The total donation by Danmark #2 is not to exceed \$3.000.00. This was greeted by a round of applause.

The Grand Secretary acknowledged the donation by Danneskjold #17

Francis Sweet, Valhalla #11, spoke of the time when at Convention Dania would hold their installation in the morning and then have a luncheon afterwards. He recalled that the last time this happened in was in Salinas and the luncheon was held up at Arne Graversgaard's house. He acknowledged that maybe the amount of Beer and Akvavit at this party may have been the reason that stopped the rest of them, but thanked Arne for the wonderful time and what a way to end it..

Grand Secretary, Tim Heer, shared a story of the 1910's Convention after party also hosted by Salinas.

The Grand Vice Marshal announced that the Law Committee returned. The Committee reported that they were well received and that Dannebrog will form a Committee to work with us during the upcoming year.

The Grand President entertained a motion that would enable us to use the revised ritual during the year while making changes to it. Grand Trustee, John Schueber, Bornholm #14 moved to preliminarily accept this revised ritual to use for the coming year. Past Grand President, Johanne Gade, and Grand Past President, Mel Lundberg, seconded the motion. Grand President, Bob Schall, called for the vote, and it was adopted.

Nomination and election of Grand Officers

Grand President, Bob Schall, appointed PGP Kaj Kristensen, PGP Arne Graversgaard, and Anne Champagne, as tellers he gave the instructions to the tellers on how to process the votes.

Grand Secretary, Tim Heer, Freja #6,, moved that in the case of one nominee that the Grand Secretary is to cast the ballot. In the event of the Grand Secretary nominee, the Grand Treasurer will cast the ballot. In the election of the Grand Vice President the Grand Vice Marshal shall carry the Ballot box to the tellers

Grand President, Bob Schall, Hejmdal #4, dismissed the tellers with thanks.

GOOD OF THE ORDER

Resolution Committee report: the Resolutions were read by Past Grand President, Stuart O. Mahler, Thyra #9, who introduced the other members of the Committee, Past Grand President, Lilian Rasmussen, Sønderjylland #10, and Past Grand President, Stanly Kjar, Thor #5. (**See addendum**)

The Grand President asked the Grand Marshal to escort Grand President elect, Thomas Martin, Danmark #2, to podium where Grand President, Bob Schall, asked the Grand President-elect to address the Grand Officers, Delegates and Members.

The Grand Vice Marshal announced that representatives of Dannebrog were outside and wished to address our Grand Lodge.

Grand President-elect Thomas Martin, turned the meeting back over to the Grand President, Bob Schall, who directed the Grand Vice Marshal to admit them.

The Grand Vice Marshal escorted the delegation to the alter where they were introduced by the Grand Marshal, Martha Nielsen, Thora #11, Dannebrog. Past Grand President, Doris Skow, Laura #8, Dannebrog spoke for the group. She made two requests. One: that the revised ritual not be used until such time as this new one is complete and approved by both Grand Lodges, and two that Dania also appoint a committee to work with the Dannebrog Ritual Committee starting within the next month to work out these little glitches.

Grand Past President, Mel Lundberg, Moved to accept the two request from Dannebrog, seconded by Grand Marshal, Steen Skjellerup. The Grand President declared this motion out of order because it conflicted with an earlier accepted motion. He asked for advice from the Grand Secretary on Parliamentary Procedure. The Grand Secretary explained how a motion to rescind is made and recommended this Parliamentary Procedure as a way to solve the issue.

John Jensen, Danmark #2, stated that he had voted on the prevailing side of the motion regarding the ritual, moved to rescind the motion regarding the Ritual. Seconded by Jackie Nielsen, Dannevang #7, the motion carried.

Grand Past President, Mel Lundberg, Moved to accept the recommendation of Dannebrog of using the current ritual, and have a committee work with the Dannebrog Ritual Committee until such time as a new ritual is completed, seconded by Grand Marshal, Steen Skjellerup. After much debate and consideration the vote was called for, the vote had seven against where only a majority would be required and the Grand President declared the motion adopted.

Grand President, Bob Schall, asked the Grand President-elect to continue his address to the Grand Officers, Delegates and Members.

Grand President-elect Thomas Martin gave a thank you to Grand Officers, Delegates and Members for all of their support and spoke of his family history, and his history with Danmark #2 and the Grand Offices he held. He then introduced his standing Committees

Grand President-elect, Thomas Martin then introduced his adviser, Past Grand President, Kaj Kristensen, Danmark #2 He then gave and explained his password. The Grand Marshal then escorted the Grand President-elect back to his station.

GRAND LODGE DANIA of CALIFORNIA-NEVADA

The very big news for this year is acquisition a wonderful Dania pin from the year 1906 from SF. That has great historical significance inasmuch as that was the year and time of the San Francisco earthquake, 5:12 AM on April 18, and, as is documented, the Annual Dania Convention was just opening that day. A huge bowl of pickled herring had been prepared for the day and, by all reports (see Dasker i Kalifornia, Binde I, by Spopus Hartwig), the herring did not go to waste.

The story of how the 1906 lapel pin came to be in our possession is truly a series of great coincidences. Our own Uffe Hellsten, sitting right over there, had purchased a home in Alameda. The home is an older, classic Victorian, apparently once owned by a Danish sea captain. Perhaps he had been a member of Odin #1 in Oakland, not so far away. Uffe found the pin under a single board he removed in the basement----and that was well before he had ever thought of joining Dania. Uffe became a member of Danmark #2 in 2014 and he found the pin years before.

But there is still a further twist to the story. Before moving to Alameda, Uffe and his wife lived in San Francisco in the same small building as my son, Jim. Jim and his wife Traci are members of Danmark #2 and Thyra #3. Jim had told Uffe about the SF branch but apparently also told him it was a bunch of "old guys drinking beer". Perhaps not far from the truth but things have certainly changed. After Uffe and some other younger guys joined, Danmark #2 has become a bunch of "middle-aged guys drinking beer"----and having a great time doing it.

The History Committee has also acquired another "Modesto 1935" lapel pin. I'm sorry, but I have forgotten from where it came.

In keeping with this Convention's emphasis on Danish Immigration, I have again added some things from my personal collection. There are two books on my family history in Denmark. There is the wooden-cover book on my grandmother's family, "Slægtsbog" and "Min Slægtehistorie" written by a third cousin of my mother's; parts have been translated by another cousin. Mother's parents were both from DK and met and married in Nebraska. Danish was the language used exclusively at home until I was in school.

Many of you will recall that during the last convention, Uffe Hellsten was looking through one of the books and found the name "Skjellerup", an unusual name. He showed it to Steen Skjellerup and Steen was delighted to find that it nicely filled in about 100 years missing from his knowledge of his family history. Perhaps he will report today on what he uncovered.

Lessons Learned:

We should advertise future events in local newspapers and community oriented web sites such as city Facebook pages and Patch sites.

Plan events far in future – Short notice is never good for generating interest and getting good attendance. The original date and announcement for the bocce party did not give enough lead time to attract members and guests.

More events at lower costs – The bocce ball party was fun but expensive, in the \$500 range. Rather than put the focus on one large event, plan many smaller events. Multiple or even regularly scheduled gatherings would better accommodate the schedules of potential new members.

The committee thanks the Grand President for the opportunity to serve our Society Dania.
