# **DANIA MEMORIAL SCHOLARSHIP FUND**

## **BY-LAWS**

**WHEREAS**, The ultimate goal of the Scholarship Fund is to establish a program with an appeal of unquestionable reliability that will attract Danish youth to participate. This fund shall be known as the “**Dania Memorial Scholarship Fund**”.

The Dania Memorial Scholarship Fund is available ONLY to members of the Danish Society Dania of California and Nevada.

An applicant to be eligible for Scholarship must meet the following qualifications:

- A. Applicant must be a member of good standing for a minimum of six (6) months in his local branch and must have paid the required membership dues to his local branch.
- B. Each Scholarship application shall be for one year only.
- C. Scholarships may be awarded only for attendance to colleges and universities accredited by one of the six United States accrediting associations or a junior college, state college, vocational or licensed trade school of advance training.
- D. All applicants seeking scholarships from the Grand Lodge must fill out an application form, obtained from the Grand Secretary by February 28, proceeding the school year for which the application for scholarship is made.
- E. Any application filed with the Grand Secretary will be reviewed by the Governing Board of the Grand Lodge prior to convention in the year filed.
- F. The scholarships shall be paid from the interest and dividends as accumulated on the resources of the Dania Memorial Scholarship Fund.
- G. The scholarship funds must be used exclusively for educational purposes: i.e., the actual and direct expenses of attending an accredited college or university in the United States. Compliance will protect the non-profit and tax-exempt status of the Danish Society Dania of California and Nevada and insure the availability of future scholarships.
- H. The Governing Board shall manage and control all business pertaining to the affairs of the Danish Memorial Scholarship Fund. Monies in this fund shall not be mingled with any other Dania Grand Lodge accounts and shall be kept in a separately held interest bearing account.
- I. When sufficient interest and dividends have accrued; the Governing Board, at an Executive Board meeting, may determine the number and amount of scholarships awarded at the upcoming convention. (revised at the 119<sup>th</sup> Convention May 21 – 22, 1999 in Monterey California)
