## RESOLUTION

### THE DANISH SOCIETY DANIA SCHOLARSHIP

**WHEREAS**, the aims and objects under the Dania Constitution reads in part, "To support such movements which, in the judgement of the Society, will advance and further its welfare"; and

**WHEREAS**, the Danish Society Dania of California and Nevada is desirous to assist in financially advancing members of its local lodges in connection with their education and schools of higher learning;

#### **NOW, THEREFORE, BE IT RESOLVED:**

1. That the Danish Society Dania of California and Nevada establish the Danish Society Dania Scholarship subject to the following rules and regulations:
  - a) An applicant to be eligible for the scholarship must meet the following qualifications:
    - 1) Applicant must be a member of good standing, for a minimum of six (6) months, of the Grand Lodge or subordinate local Branches of the Grand Lodge Dania where applicable, must have paid the dues to the local Branch or Grand Lodge, which would entitle the member to the full benefits of the respective Branches. Or, be the son or daughter of a member in good standing for a minimum of six (6) months.
    - 2) An applicant will be ineligible for the scholarship if he has, prior to filing an application, received four (4) Danish Society Dania Scholarships. (revised at the 119<sup>th</sup> Convention in Monterey California May 21- 22, 1999)
  - b) All applicants seeking scholarships under the terms of the Resolution must fill out an application form provided by the Grand Lodge and return the completed application through the secretary of their local branch to the Grand Secretary by February 28 preceding the school year for which application for scholarship is made.
  - c) Any application filed with the Grand Lodge will be reviewed by the Executive Committee of the Grand Lodge when convention convenes in the spring. Each member will vote for three whom they feel are best qualified to become recipients in accordance with the voting procedures of the Grand Lodge. The names of these participants who have received the three (3) greatest number of votes will receive the scholarships. The names will then be announced at the Convention.
  - d) The amount of any scholarship granted by the Grand Lodge will be an amount not to exceed \$400.00 for three quarters full attendance at a recognized Junior College or an accredited College or University. (revised at the 124<sup>th</sup> Convention in Ferndale California April 16 & 17, 2004)
  - e) The cumulative total of all scholarships granted by the Grand Lodge for any one calendar year shall not exceed the sum of \$1200.00. (revised at the 124<sup>th</sup> Convention in Ferndale California April 16 & 17, 2004)
  - f) The number and dollar amount of the scholarship may be changed at any Grand Lodge Convention.

**BE IT FURTHER RESOLVED**, that the essence and meaning of this Resolution and the intention of the Grand Lodge is to aid the applicant in his efforts to complete his education in a school of higher learning, believing that in accomplishing this, benefits will accrue to the member.

**BE IT FURTHER RESOLVED**, that upon the adoption of this Resolution, single sheets thereof shall be spread and affixed upon the Minute Book of the Grand Lodge of Dania as of the date of the adoption of the Resolution.
