RULES, REGULATIONS AND POLICIES RE: APPLICANTS FOR THE GRAND LODGE DANNEBROG SCHOLARSHIP

- 1. An applicant must be a member in good standing for a minimum of six (6) months of the Grand Lodge Dannebrog or a subordinate local branch of the Grand Lodge Dannebrog, where applicable; or be the child (boy or girl) of a member in good standing for a minimum of six (6) months.
- 2. An applicant will be eligible for a scholarship upon completion of high school graduation.

2(a) See #3 on the application.

- 3. Applicants may apply as often as they wish; however, no more than four (4) scholarships will be granted to any one applicant.
- 4. All applicants seeking a scholarship under the terms of this Resolution must fill out an application form provided by the Grand Lodge; return the completed application to the Grand Secretary by **February 15** preceding the school year for which application for a scholarship is made.
- 5. Any application filed with the Grand Lodge will be reviewed by the Executive Committee of the Grand Lodge prior to Convention in the spring. The name(s) of the recipient(s) will be announced at the Convention meeting.
- 6. A separate interest earning account will be set up for the Fund, with the Executive Committee in charge of administering the account, and a detailed accounting presented yearly for audit.
- 7. The amount of the scholarship granted by Grand Lodge will be an amount of \$200 not to exceed 10 scholars for full time attendance at a recognized and accredited (a) Licensed Trade School of Advanced Training, (b) Community College, (c) State College, (d) University, or (e) GED.
- 8. The total of all scholarships granted by the Grand Lodge in one year shall not exceed one quarter (1/4) of the balance in the Fund.
- 9. The number of scholarships and the dollar amount may be changed at any Grand Lodge Convention.
