
140th Annual Grand Lodge Dania Convention Report

Grand President Jana Heer appointed Past Grand President, PGP Glen Fritz to fill the Office of Grand Vice Marshal.

The Grand Officers were instructed to take their respective stations and the Acting Grand Vice Marshal Glen Fritz, to close the door at 9:05 A.M.

The password was taken by Grand Marshal Tom Martin and Acting Grand Vice Marshal Glen Fritz. After the password was obtained the Grand President called for the opening sign.

Grand President Jana Heer spoke on how special this convention is and how we have been waiting for 2 years to hold it. She thanked the Officers and Members for their dedication and patients during the extended time and in an efforted to honor them she asked that as your name is called to stand and remain standing until all the names in your group have been read. Then Grand President then asked the Grand Secretary Tim Heer, to call the roll of Grand Officers, Representatives and Past Grand Presidents. 9 Grand Officers, 10 Past Grand Presidents and 17 Representatives responded to roll call. It was noted during the calling of the Roll of Representatives of Danmark #2 that Alt James O. Jensen was taking the place of Ian Nielsen. After each Group they were greeted by a+ round of

applause. The Grand Secretary reported that the Quorum requirement to hold a convention has been stratified with 17 Representatives in attendance.

The assembly then rose to recite the pledge of allegiance to the flag of the United States of America followed by the singing of Der er et Yndigt Land, which was supplied on a song card written in English and Danish this year.

Grand President Jana Heer asked the Grand Secretary to read the name of those who had passed away since our last convention. After the list of three Past Grand Presidents, one Past Grand Trustee and twenty-one members were read. The Grand Marshal was asked to drape the Charter in memory of our departed Members while the Grand President recited a section from the Dania Local Lodge funeral ritual, after which everyone stood for a moment of silence in honor of our departed Members.

Grand President Jana Heer welcomed everyone to the convention and thanked everyone for taking this brave step into the normal. Thanked Bornholm #14 for all they went through over the last two years to organize this event. She then proclaimed the 140th Annual Convention of The Danish Society Dania of California and Nevada in session with full powers and authority to act on all subjects brought before this session, in accordance with the Constitution of the Grand Lodge.

Grand President Jana Heer informed the membership that she has come prepared with her agenda, her gavel, the same one she used as Grand President of Dannebrog 2004-2005. She also said that she has a few extras in my toolbox to assist her in seeing that order is maintained as per Article 9 Sec. 3 Par. 12 in the Constitution, her Dannebrog, a timer, and a whistle. She listed a few reminders; 1) To attend meetings on time, 2) When you wish to speak, for any reason, including points of order and calls for the question, please stand quietly and wait to be recognized, you might want to use that time to take a deep breath. 3) Upon recognition, please give your name and branch. And 4) Please quiet your phones now if you haven't already.

Grand President Jana Heer instructed Grand Marshal Thomas Martin to escort her advisor, Past Grand President Steen Skjellerup, to the chair on her right to act as co-advisor during the Convention.

As the first Grand President of Dania to have served as a Grand President of Dannebrog, she wanted to bring to Dania some of the flavor of how Dannebrog goes about their meeting so the Dania may have a better understanding of Dannebrog's traditions. She pointed out that Dania Grand Lodge Agenda does not include an opening statement, so she used the one from the Dania Locale Lodge ritual. She followed that with the one that the Grand Lodge of Dannebrog uses when they open their Grand Lodge session.

Grand President Jana Heer asked Grand Secretary Tim Heer to read the minutes from our previous Convention. The Grand Secretary moved that the Annual report of 2019 be approved as distributed, seconded by PGP Tom Martin. The motion was adopted. The Grand Secretary then read the minutes from the close of the 139th Convention to the opening of this Convention. It was moved by Past Grand President Tim Heer, that we accept the report, seconded by PGP Tom Martin. The motion was adopted.

Grand President Jana Heer declared a Coffee recess at 9:55 A.M. to reconvene at 10:10 A.M

Grand President Jana Heer asked for all those who were not in the morning session to stand, there being no one standing, he reconvened the meeting.

The Grand President recognized the Grand Secretary who move to allow Bruce Bro who is the U.S. Vice President

of Rebild National Park Society, and President of the "National Foundation for Danish America" to attend our meeting as a visitor. Seconded by Grand Trustee, Johanne Gade, Bornholm #14, The motion was adopted. Bruce Bro was welcomed. Bruce was asked to introduce himself. Bruce extended greetings from the Members and officers of Rebild National Park Society and explained what the National Foundation for Danish America is trying to do in its effort to report the activities of all Danish American clubs activities in America including Dannebrog and Dania.

Report of the Grand President: Grand President Jana Heer instructed the Grand Vice President Bente Ellis to take charge of the meeting as she gives her annual report.

After being installed in April 2019 my first newsletter message was full of optimism and excitement for the coming year of Dania &Dannebrog activities. And for the most part that became a reality. In May of that first year, Reno's installation with great food among great company, is always a successful event especially for the newly installed officers, Reno is always very forgiving of missteps and fumbled speeches. I enjoyed the honor of presenting a member with their 50 year pin. Next on the list was camping with the fun-loving Danish Campers at Casa de Fruta. A little down pour didn't put a damper on the campers and as a plus we met some REAL Danish campers. In June, Fresno's picnic in the backyard of Don and Christie Pettitt, gave me another opportunity to present several 25 year pins, only one of the recipients, Steen Skjellerup, got his on time on time, the others a little overdue, but all gracefully received. I have many memories of joking and laughing around a campfire with Don Pettitt and I was deeply touched by the sight of his tears as I pinned his father-in-law's Past President pin on him. I was also able to present Dania Scholarships to siblings Aaron and Rebecca Holt, young members who are actively involved in the local Danish community. Then a year later, I became a member of the Fresno Danish dancers and found myself learning dance steps and benefiting from their youth, vigor and patience with my first awkward attempts. I'll never forget Fourth of July picnic in Santa Maria. Colorful tents and banners among the trees with the sound and scent of perfectly seasoned of Tri Tip steak wafting through the air. I had the honor of presenting the first of many 25 and 50 years pins that day and came home with a stack of homegrown homemade apple pies. In August, Sønderjylland's installation in the magical Kastania Fælled in Petaluma I was deeply inspired by outgoing President Karen Friss Lysmer and incoming President Debbie Cruger-Hansen's lovely and loving presentations. Kastania Fælled is by far the most beautiful backdrop for a Dania installation, I encourage everyone not to miss the opportunity to enjoy Sønderjylland wonderful hospitality. In September, unfortunately Modesto's Bornholm had to cancel their installation due to illnesses and low turnout. I was sorry to miss that Dania "one man show" installation. I also missed out on Dannevang and Danebod's BBQ in Livermore, because suddenly and sadly I was needed on the home front. Missing installing Ferndale was a big disappointment for me too, but I wished I had the where with all to have someone video the installation so I could have seen the fine and most certainly very entertaining Grand Marshal team of Stuart Mahler and Tim Heer, and I'm sure Beth enjoyed installing alongside our Past Grand President and current Grand Marshal Tom Martin. Then, missing Danish Days in Solvang? . . . well, it was a rough couple of months.

In October 2019 I timed my visit to Hayward's meeting held at the home of Greg Gleeson just in time to bid farvel to Alan and Mary Ester Filiau before they moved to their new home in Minnesota. That same month, my home lodge in Salinas enjoyed our annual re-installation of old officers and are always grateful to see our tables full of guests and appreciate the Grand officers extra effort to install our small core of officers into multiple positions. As we like to call it the Salinas Installation Shuffle.

Next, Christmas parties in December, remember those? San Francisco, Hayward, and Modesto kept me in the spirit and had me singing Christmas carols all month. Then, in January 2020 I witnessed the closing of San Jose's Laura #8 of Dannebrog. It was a bittersweet moment, and the members were making a unified effort to figure out how it will all work with everyone being members of Dania. I know that San Jose did everything they could to avoid this happening, but it reaffirmed my resolve to find a way for Dania and Dannebrog to move into the future without any branch having to give up their charters.

At this point in my life I had changed my zip code to 93711, Fresno. Which made it a short drive to participate their

installation, the Valentine theme was very appropriate much appreciated. Speaking of hearts, I always love going back to San Francisco to retrieve mine, Danmark #2 was where my relationship with Dania all started. Then an installation in Livermore is always special in that nice old roomy building. Only one plant from my mini succulent garden I received as a gift has survived and is over 4 feet tall now.

In February in anticipation of Convention in April I was encouraging members to venture out into new territory by "switching sides". I will continue to encourage this, there's a chance that any blending of Dania and Dannebrog will only happen naturally and not by some laborious effort. I was also predicting that, "Soon we'll be getting back into the swing of good times in D&D with the last of 2019-2020 Branch installations followed closely by convention in April". We all know that that wasn't in the cards.

The first two weeks in March we started hearing more about this new Coronavirus, and during that time I was able to attend the last few gatherings before life as we knew it experienced a huge shift. First, my new traveling companion, Steen Skjellerup, and I attended Solvang's Heils Minde#23 meeting. The spirits were high as they celebrated the return to the newly renovated meeting place, the Bit o' Denmark. We enjoyed wonderful food, singing, and visiting.

Everyone was happy to be in Modesto for the much anticipated annual Fish meal, this year they served Lunch. The tables were overflowing with food and beverages and the room was packed with happy smiling, not yet masked, faces as we all practiced the new elbow bump greeting. Next, we made the trip to my home lodge in Salinas for our annual March St. Patty's Day meeting. This has always been a special one for the Heer family to celebrate our father's Irish heritage. In 1911 as a young teenager his mother immigrated from Ireland to San Francisco to help her recently widowed uncle and his very young children. I hadn't attended a Rebild meeting since I was Grand President of Dannebrog in 2005 and lived right down the street from Aldersly in San Rafael. Since then, I've gotten to know so many members of Rebild and I was excited to attend the annual planning meeting of San Francisco Chapter of Rebild at Anderson's Pea Soup Restaurant in Santa Nella. It was just one day before everything "shut down" on March 15th, 2020. All organizations found themselves in the same dilemma. Extremely uncertain of what was ahead but moving forward with plans as if nothing was changing. Within a few days later it became painfully obvious that Convention was going to have to be postponed till 2021. Which also meant that Hayward had to cancel their installation, an important event especially for Dannebrog's Grand President Beth Cowan, she's still waiting to install her own branch.

I started off my 2020 Grand President messages expressing my hopes for our upcoming convention in April, "This is my sincerest wish and will be my #1 priority that all voting members will walk away from deliberations feeling that their voices were heard, and opinions respected." I still fell that way and I know we can do it.

Where did the last two years go? Really, it feels like a blur.

The Last 24 months have been less about me and more about all of us with all you did and all your effort to remain healthy. By social distancing would ultimately bring us all together. Thank you all, the Grand Officers especially for remining in your Grand Office for those two years and keeping in touch through all of the virtual Executive meeting, thank you Jr. Past Grand President, John Scheuber and Grand Secretary Tim Heer for making that happen. As many of you know Dania does pay me for my traveling expenses and with the pandemic I did not do a lot of traveling and no one was having installation, so I am going to reimburse Dania my traveling expenses I received every month with this check for \$2,022.00.

The Grand Vice President asked the Delegations what are our wishes regarding the report of the Grand President. It was moved by Grand Secretary, Tim Heer, Freja #6, that we accept the report of the Grand President, seconded by Jr. Past Grand President, John Scheuber, Bornholm #14. The Grand Vice President ruled that the motion was adopted, and then returned the meeting back to the Grand President.

Minutes of the Executive Committee: The minutes of the meetings held on March 15-19, 2020, March 26, 2020, April 23, 2020, November 23, 2020, March 20, 2021, May 27, 2021, and February 24, 2022 were read by the Grand Secretary. It was moved by Grand Marshal, Tom Martin, Danmark #2, to approve the minutes of the Executive

Committee, seconded by James O Jensen, Danmark #2. The motion was adopted. The Minutes are attached to this report.

Grand Secretary's Report: In the interest of time The Grand Marshal and Grand Vice Marshal handed out the reports of the Grand Secretary, Grand Treasurer and The Grand Trustees before the meeting opened. The Grand Secretary's annual reports for 2019, 2020, and 2021 were read. The Grand Secretary's reports are attached at the end of this report. The Grand Secretary continued his report and called the Member's attention to the itemized reports of the Branches on Membership, Assets, Receipts, and Disbursements for review. A complete copy is attached to this report. It was moved by Grand Secretary, Tim Heer, Freja #6 to accept the reports. Seconded by Daniel Barney, Valhalla #11, the motion was adopted.

Grand Treasurer's Report: Grand Treasurer, Gregory Gleeson, presented the Grand Treasurer's annual reports for 2019, 2020, and 2021 for review. Past Grand President Tom Martin moved to accept the report, seconded Past Grand President, Steen Skjellerup, Thor #5 and the motion was adopted. The Grand Treasurer's reports are attached at the end of this report.

Grand Trustees' Report: Grand Trustee #1 Past Grand President, Johanne Rasmussen Gade, Bornholm #14 presented the Grand Trustees' annual reports for 2019, 2020, and 2021 for review. Past Grand President Tom Martin moved to accept the report, seconded Past Grand President, Steen Skjellerup, Thor #5 and the motion was adopted. The Grand Trustees' reports are attached at the end of this report.

REPORT OF STANDING COMMITTEES

History Committee Report: Grand President called on Grand Marshal, Past Grand President Thomas Martin to give a report. He explained the items on the back history table and reported that all of the items in the History Committee's possession have been moved to the last remaining Dania Hall located in Ferndale for safe keeping.

Report from the Advisory Committee: Past Grand President Steen Skjellerup reported on behalf of the Committee's members, Past Grand President Lilian Rasmussen, and Past Grand President Robert Lacey, that there were two items. They recommended that all 39 changes to the Constitution be handled as one motions. They also recommended that each local Branch keep the Grand Secretary up to date with their membership contact information to make sure that all members are receiving a monthly newsletter. Past Grand President Tom Martin moved to accept the report, seconded by Karen Lysmer, Sønderiylland #10 and the motion was adopted.

Report from the Membership Committee: The Grand President asked the Grand Secretary to read the report submitted by Ole M Pedersen, Chairman: The Danish Societies of Dania & Dannebrog have a glorious past, rich with History, tradition and experiences enjoyed by our membership for more than a Century. It is time to look towards the Future and work on what we as members want the Societies to be in the Future and to find a purpose for their existence that goes above and beyond what we have been and are now. One of the reasons is that we want to be 'relevant' and thereby make it more interesting for people to join the Societies as members.

Another reason is that our rich Danish Heritage in the widest sense is meaningful, valuable and important to pass on, not only to our descendants but because our heritage can make a positive contribution to the Peoples of the World. We suggest that we discuss and brainstorm about our mutual future of our Danish Societies in the year leading up to the 2021 Convention and put it on the agenda for the Convention. Our suggestion is that the discussions take place in the individual Lodges at meetings and gatherings, at the Grand Lodge level and in this Newsletter. The common theme is suggested to be:

"What do we want the Societies to be in the Future and how can we make sure the Societies can survive and prosper in the decades to come?"

"We need more members!". We hear this spoken often, not just in our own organization, but in many others as well. If we fail to act, there is a very high possibility that the decline in membership will continue and we'll eventually have to 'close up'.

Proposal:

That the Societies set up a grant/stipend/scholarship or something of that nature where an applicant will be awarded \$3000-\$4000 to cover, in part, participating in the studies of Literature and History at a Danish Folk High School in Denmark. The condition would be that upon returning to the US, the applicant would visit all Lodges, and perhaps the Convention, and communicate the experience.

There are about 70 Folk High Schools, the best known is probably Askov:

Grand President Jana Heer declared a Lunch recess at 11:55 A.M. Convention to reconvene at 2:00 P.M

Before reconvening, The Grand Secretary moved to allow a visitor to be present during the afternoon session. It was moved seconded and approved to allow the visitor. The Grand President Jana Heer then welcomed her sister Pat Anderson, who was visiting from Lynden Washington, and is a member of Dannebrog

Grand President Jana Heer asked for all those who were not in the morning session to stand, there being no one standing, she reconvened the meeting. She then explained the procedure that Dannebrog follows that allows them to tell if a member had not returned after lunch.

The report of the Nominating Committee: The Grand President call on the Jr. Grand Past President John Scheuber for his report. He explained that they have three Grand offices still open. He reported the nominations as follows: Grand President, Bente Ellis, Grand Vice President, Thomas Martin, Grand Secretary, Tim Heer, Grand Treasurer, Greg Gleeson, Grand Vice Marshal, Robert Lamee, Grand Trustee #1 Johanne Gade. Grand Marshal Tom Martin mover to except the Nominating Committee's report seconded by Daniel Barney, Valhalla #11. The motion was adopted.

Report of the Legacy Committee: As the Chairman was not in attendance, this was tabled until the next convention.

Report of the 65 Year Pin: The Grand President called on the Grand Secretary for his report. Who explained his idea of an engraved disk that would fit behind a membership pin. Grand Treasurer Greg Gleeson moved to accept the report it was seconded by Grand Marshal Tom Martin and the motion was adopted.

Report of the Constitution Committee: The Grand President call on Chairman Bob Lamee for his report. He introduced his committee; Tracey Lamee, Stuart Mahler, John Jensen; Jana Heer and Tim Heer. He then present the Committee's proposed changes to the constitution. He went over some of the changes and additions in detail. The then thank this current committee and the two other pervious committees for all of their hard work that went into these proposed changes. Grand Secretary Tim Heer moved to accept the Committee report, seconded by Grand Marshal Tom Martin. The motion was adopted.

The Grand President: asked the Grand Secretary to clarify what is the procedure when changes to the constitution are proposed at a convention. The Grand Secretary reference Article VI of the constitution that a committee on Laws shall examine all proposals for new laws or amendments.

Grand President Jana Heer declared a Coffee recess at 3:08 P.M. to reconvene at 3:28 P.M

The Grand President asked the new members to introduce themselves as Colleen Heer Cave, Natalie Heer, Freja #5 and John Jensen, Danmark #2. The Grand Secretary moved to allow Colleen Heer Cave as a visitor to the afternoon session, Seconded by Grand Marshal Tom Martin. It was moved seconded and approved to allow the visitor. The Grand President Jana Heer then welcomed her sister Colleen Heer Cave who is a member of Dannebrog, her sister in-law Natalie Heer who is the Grand Secretary of Dannebrog and John Jensen to our afternoon meeting.

UNFINISHED BUSINESS

Grand President Jana Heer asked if we had any Unfinished Business.

NEW BUSINESS

Grand President Jana Heer; recognized Grand Secretary Tim Heer who moved to suspend the approved method of presenting changes to the Constitution at this convention only Seconded by Past Grand President Daniel Joensen. The Motion was adopted

Grand President Jana Heer; recognized the Chairman of the Law Committee Past Grand President Steen Skjellerup reported that they did not find any issues with the proposed changes to the constitution as presented by the Constitution Committee. It was moved by Aiden Jobe Sea, Danmark #2 to accept the report of the Law

Committee, seconded by Grand Trustee #1 Past Grand President Johanne Gade. The motion was adopted.

Grand President Jana Heer; recognized Jr. Grand Past President John Scheuber who moved to accept all of the changes to the Constitution as presented by the current Constitution Committee, seconded by Grand Trustee #1, Past Grand President Johanne Gade. The Grand President requested that copies of the changes be passed out to the delegates. The motion was adopted unanimously follower by a loud applause which required the Grand President to use her whistle to quite the crowd.

Grand President Jana Heer asked the Grand Secretary to present the bills.

Grand Secretary Tim Heer Freja #6 moved to pay the Grand Treasurer \$100.00 per month expense reimbursement, it was seconded by Grand Marshal Tom Martin Danmark #2. The motion requires a two-thirds majority vote to pass, the vote was unanimous the Grand President ruled the motion was adopted.

Grand Secretary Tim Heer moved to pay the Grand Trustees \$1.00 each per year expense reimbursement; it was seconded by Grand Marshal Tom Martin Danmark #2. The motion requires a two-thirds majority vote to pass, the vote was Yes 18 No 2 the Grand President ruled the motion was adopted.

Grand Secretary Tim Heer moved to set the Funeral Benefit at \$200.00, seconded by Grand Marshal Tom Martin Danmark #2. The motion requires a two-thirds majority vote to pass, the vote was unanimous the Grand President ruled the motion was adopted.

Grand Secretary moved to set the annual per capita tax at \$30.00 per member to be paid in two installments, with the exception of those Branches that have a net worth less than \$5,000.00, in which case their amount would be \$20.00 per member, seconded by Grand Marshal Tom Martin Danmark #2. The motion requires a two-thirds majority vote to pass, the vote was Yes 19 No 1 the Grand President ruled the motion was adopted.

Grand Secretary moved to donate \$25.00 to the Danish American Historical Society in Fresno, seconded by Grand Marshal Tom Martin Danmark #2. The motion requires a two-thirds majority vote to pass, the vote was unanimous the Grand President ruled the motion was adopted.

Grand Secretary moved to donate \$25.00 to the Elverhøj Museum of History and Art, seconded by Grand Marshal Tom Martin Danmark #2. Bent Olsen, Hejls Minde #23 moved to amend the motion to donate \$75.00 seconded by Aiden Jobe Sea, Danmark #2. The motion to amend requires a two-thirds majority vote to pass, the vote was unanimous the Grand President called for a vote on the motion as amended also requires a two-thirds majority vote to pass, the vote was unanimous the Grand President ruled the motion as amended was adopted.

Hi all, hope you are all staying well!

Thanks for sharing this John, I know this virus been on all our minds (hopefully no where else!). Tim, Nat and I have each received inquiries from members regarding the status of our convention planning. I've spoken to Beth Cowan on the phone on Friday as well as Tracey and Robert Lamee that evening. I also saw Tim, Natalie, Johanna and Bente at the Rebild meeting yesterday. We're all concerned about how we should be responding to this situation. I've been told that Modesto has received several cancellations so far. According to the Dania Constitution, Article 3, section 2, Paragraph 1:

Par. 1. In case of wars, epidemics or other elements endangering the public welfare, the Grand President together with the Executive Committee shall be empowered to postpone a regular convention until such state of urgency has been overcome, but must call a regular convention within six months after the conclusion of such a state of urgency.

So I've been thinking about what I as Grand President of Dania should be doing right now, and the first thing I'd like to do is make a written statement to all our members reassuring them that the Grand Lodge is taking this very seriously, that Dania's Executive Committee is discussing this, that it will be at the top of our agenda on Saturday (that is if Hayward doesn't cancel their installation), that the host lodge is working with the Hotel and that we will inform everyone as soon as we've decided on a plan of action. I think that I should do this immediately, everyday something new develops, the public is being worked up into a frenzy, I don't think we should keep our members wondering what Dania is doing about this. I can only speak for Dania, on Friday Beth said she wants to wait till the Executive meetings on Saturday to take any action, but agrees with me that this decision should reflect the input from both Dania and Dannebrog. But for now, our members need to know that we are not ignoring this threat. I'd like to hear from all of you regarding this.

"Counties across the region have issued public orders banning gatherings — including at restaurants, bars and theaters — of <u>as few as 10 people</u> unless all attendees can be 6 feet away from each other and prospective attendees are warned they face a higher risk of coronavirus infection. Each county issued various rules. San Mateo County placed limits on gatherings of 10 or more people and officially banned those of 50 or more; Santa Clara County on Friday <u>restricted</u> gatherings of 35 or more and banned those of 100 or more.

<u>San Francisco</u> and <u>Contra Costa County</u> banned all nonessential events of 100 or more people. Alameda County suggested all gatherings of 250 or more be canceled. San Francisco also banned visitors and nonessential personnel from hospitals and psychiatric hospitals.

Officials called the rules radical but said they were needed to battle the virus. "These measures are designed to slow the spread of disease and preserve critical healthcare capacity and other essential services," said Santa Clara County health officer Dr. Sara Cody."

Re: Potential Convention Dates

I just completed a long conversation with Jocelyn Venable, Sales Manager for The Clarion, and she is being quite accommodating in an effort to resolve our convention dates in light of the pending Coronavirus situation.

These are some summer and fall dates in 2020, assuming the virus is no longer an issue and if we elect to have a convention prior to next year:

August 13-15

August 20-22

September 10-12

September 24-26

October 15-17

She is also able to let us put this off for an entire year to 2021, with this date:

April 15-17

Please send this to your Grand Officers and Executive Committees, as appropriate. Once both Grand Presidents are informed and have some of the Grand Officer input, I would suggest that both Executive Committee (Dania & Dannebrog) members call into a conference call at a date and time to be determined. I have an 800 conference # we can use.

As a start I would suggest we have this call on Wednesday, March 18 at 7pm, or Thursday, March 19 at 7 pm. Let your Grand President know what date works for you.

ARTICLE III

THE CONVENTION OF THE GRAND LODGE

Section 2

- Par. 1. In case of wars, epidemics or other elements endangering the public welfare, the Grand President together with the Executive Committee shall be empowered to postpone a regular convention until such state of urgency has been overcome, but must call a regular convention within six months after the conclusion of such a state of urgency.
- Par. 2. If conditions should prevent the Grand Lodge from holding a yearly convention, the present Grand Officers and all regulations shall continue through the next succeeding convention.

If a grand officer doesn't want to retain their office, we do what we've been doing this year and fill in as needed at an installation.

As for the local branches, I say we do the same. We're going to have to be flexible.

In addition to the questions John and Jana brought up, I would also add how we pay the bills? Can that be done remotely by the Executive Committee? I think a conference call to talk about these things would be great.

Thanks, John, to you and the convention committee. I know this has been difficult.
