The password was taken by Grand Marshal Dan Holm and Grand Vice Marshal Robert Lamee. After the password was obtained the Grand President called for the opening sign. Grand President admonished all that any Cell phone going off from this point forward would result in a fine.

Grand President Bente Ellis asked the Grand Secretary Tim Heer, to call the roll of Grand Officers, Delegates and Past Grand Presidents. 10 Grand Officers, 22 Delegates responded and 14 Past Grand Presidents to roll call. Doris Skow, Danneskjold #17 and a Past Grand President of Dannebrog, was recognized and was very pleased to still be active and happy to be a member of Dania and is enjoying her first Grand Lodge meeting as a Delegate at this convention.

Report of the Nominating Committee: Grand Trustee #3, John Scheuber, reported that the office of Grand Vice Marshal and Grand Trustee #3 are open.

Grand President Bente Ellis declared a Coffee recess at 10:20 A.M. to reconvene at 10:51 A.M.

Grand President Bente Ellis asked for all those who were not in the morning session to stand, The Grand Secretary introduced one member that was not at the morning session, a Delegate from Valhalla #11 Tamara Barney. The meeting was reconvened.

The Grand Secretary asked to speak on our IRS Tax exempt status, thanks to Danmark #2 we have a hand out that explains a 501(c8) as a non-incorporated self-promoting organization which benefits to its members only. As it is the month of April reminded the membership that any donation made to our organization does not qualify as a Tax deduction on your personal Income Tax. He also reminded the members that local Branches can make donation out of their Branch's funds to Grand Lodge charities: the Senior Assistance Fund, Memorial Scholarship or the General Fund Scholarship. Branches making donations to 501 (c3) organizations could result in our organization's loss of our exempt status. The hand out is attached at the end of this report. He also pointed out that he had copies of the Senior Assistance Fund application form on his desk for those that maybe interested. This was followed by many questions regarding our relation with Dannebrog, which were left unanswered and no onion was offered as to how we should handle reimbursements between the two Bodies.

Grand President Bente Ellis; asked Grand Vice President, Tom Martin to explain the proper etiquette and how the Voting Members are to act during a session at Grand Lodge. It was recommended that The Grand Secretary provide all Grand Officers with a hand book covering requirements of their Grand Officers before the next convention and a hand out for all voting members regarding etiquette at the next convention.

Grand President Bente Ellis asked the Grand Secretary to present the bills.

Grand Secretary Tim Heer moved to pay the Grand Treasurer \$100.00 per month expense reimbursement; it was seconded by Danial Barnet, Valhalla #11. The motion was accepted unanimously.

Grand Secretary Tim Heer moved to pay the Grand Trustees \$1.00 each per year expense reimbursement it was seconded by Danial Barnet, Valhalla #11. The motion was accepted unanimously.

Grand Secretary Tim Heer moved to set the Funeral Benefit at \$200.00 it was seconded by Danial Barnet, Valhalla #11. The motion was accepted unanimously.

Grand Secretary moved to set the annual per capita tax at \$30.00 per member to be paid in two installments, with the exception of those Branches that have a net worth less than \$5,000.00, in which case their amount would be \$20.00 per member. Seconded by Grand Treasurer, Gregory Gleeson. The motion was accepted unanimously

Grand Secretary moved to donate \$75.00 to the Danish American Historical Society in Fresno, it was seconded by Danial Barnet, Valhalla #11. The motion was accepted unanimously

Grand Secretary moved to pay \$45.00 annual dues to Aldersly, it was seconded by Danial Barnet, Valhalla #11. The motion was accepted unanimously.

Grand Secretary moved to donate \$75.00 to the Bethel Lutheran Home Selma, it was seconded by Danial Barnet, Valhalla #11. The motion was accepted unanimously.

Grand Secretary moved to donate \$75.00 to Atterdag Village Solvang, it was seconded by Danial Barnet, Valhalla #11. The motion was accepted unanimously.

Grand Secretary moved to support the Web Site Committee not to exceed \$300.00 it was seconded by Danial Barnet, Valhalla #11. The motion was accepted unanimously.

Grand Secretary moved to set the Grand Presidents traveling expenses at \$1,200.00 a year it was seconded by Danial Barnet, Valhalla #11. The motion was accepted unanimously.

Grand Secretary moved to set the Grand Marshal traveling expenses at \$600.00 a year it was seconded by Danial Barnet, Valhalla #11. The motion was accepted unanimously.

The Grand Secretary pointed out that due to the resent changes to the Constitution, the Traveling expenses are easier to handle, and that the Constitution states that the host Lodge of a Convention will receive \$300.00 so there is no need to vote it out as a bill.

Grand Treasurer moved to pay the Grand Secretary \$200.00 per month expense reimbursement, it was seconded by Danial Barnet, Valhalla #11. The motion was accepted unanimously.

Grand Treasurer moved to pay the Newsletter Publisher \$100.00 per month expense reimbursement for the printing of the Monthly Newsletter it was seconded by Danial Barnet, Valhalla #11. The motion was accepted unanimously.

The Grand President asked if there was any other new business. Past Grand President, Steen Skjellerup, moved to have the Grand Secretary research if the Grand Lodge has to be registered with the California State Secretary. Seconded by Grand Trustee, John Jensen, the result of the vote was Yes 18, No 5, the motion was accepted.

Nomination and election of Grand Officers
